The explosion of the internet has led to the proliferation of legal websites. The Australian Bureau of Statistics<sup>1</sup> reports that internet access has quadrupled in Australian households in the last ten years, reaching 72 per cent in the 2008-09 period. There were 9.6 million active internet subscribers in Australia at the end of June 2010, and 92 per cent of the connections were not dial-up.2

#### **ONLINE SAFETY**

The exponential expansion of the internet has been paralleled by a corresponding growth in those who use it for nefarious and illegal ends. There are a few basic points to remember, which can make the internet experience safer:

- Close browser pages down before leaving the office. This reduces the opportunity for hacking.
- Keep anti-virus software current and operating to keep up with new dangers.
- Use caution when providing personal information on social networks.
- Phishing occurs when emails are sent from sources that can look like bona fide organisations but are intended to obtain information such as user names, passwords and credit card details. The emails will typically link to a website that might look genuine but is fraudulent. Check

sources before providing any information.

### **WEB BROWSERS**

Browsers do the work of retrieving resources on the web; they are essentially software applications which search and locate information. Apple developed its own browser called Safari, although other browsers can also be used on a Mac. Windows PC users will be familiar with Internet Explorer. However, there are other browsers which offer users choice.

#### Mozilla Firefox

This browser allows customised searching with a huge choice of 'add-ons', which are applications to enhance searching. For example, there is an add-on to store favourites on a server. If your computer crashes, the favourites can be retrieved. Another add-on blocks advertisements.

# **Google Chrome**

Chrome has a reputation for being fast. It is customisable and also provides an 'incognito mode' if you don't want your website visits to be recorded in the browser history.
